Call to Order

The Stated Meeting of Grace Presbytery was called to order with prayer by Presbytery Moderator **Rev. David Schaefers** at 9:00 a.m. on June 1, 2019 at First Presbyterian Church of Fort Worth, Texas.

Worship

The Lord's Supper was celebrated during worship. Worship was led by Ruling Elder Martin Osae (Commissioned Pastor for the Ghanaian Fellowship at Woodhaven Presbyterian Church, Irving), Rev. Offering

An offering of \$2,730.47 was received for scholarships for first-time Grace Presbytery participants attending PCUSA-sponsored children and youth camps or conferences.

Quorum, Welcome, Docket

The moderator declared a quorum was present in accordance with the current version of the Standing Rules and Manual of Administrative Operations of Grace Presbytery, Section 1.5.3: "A quorum for presbytery meetings shall be ten percent of the teaching elders currently on the roll of the presbytery and one ruling elder commissioner from ten percent of the congregations on the roll of the presbytery." The docket was approved as presented. The host, **Rev. Michael Waschevski**, welcomed the presbytery. First-time ruling elder commissioners were recognized.

Reports

The General Presbyter **Rev. Janet DeVries** gave the following report:

(Luke 4:16-21): ¹⁶ When he came to Nazareth, where he had been brought up, he went to the synagogue on the sabbath day, as was his custom. He stood up to read, ¹⁷ and the scroll of the prophet Isaiah was given to him. He unrolled the scroll and found the place where it was written: ¹⁸ "The Spirit of the Lord is upon me because he has anointed me to bring good news to the poor. He has sent me to proclaim release to the captives and recovery of sight to the blind, to let the oppressed go free, ⁹ to proclaim the year of the Lord's favor." ²⁰ And he rolled up the scroll, gave it back to the attendant, and sat down. The eyes of all in the synagogue

were fixed on him. ²¹ Then he began to say to them, "Today this scripture has been fulfilled in your hearing."

Six years ago, I had the opportunity to travel with three members of Grace Presbytery to Israel and the West Bank (also known as Palestine). For years I had been wanting to make this trip both to understand my religious heritage and also to talk with Jews and Palestinian Arabs, including both Muslims and Christians. I have now been there six times and seen deep changes, most of which I find disturbing. And I became committed to enabling members of this presbytery to create their own opinions by being in situations where they were the minority among Jews or among Arabs, but frequently in the company of Palestinian Christians. I must add that I have never personally felt in danger on any of these trips, and I believe our trip participants would say the same to you.

Traveling internationally into areas with deep differences was not new to me, but this one pushed my own religious predispositions and attitudes deeply. I had grown up during the 1950s and 1960s when civil rights were deeply ingrained in my being through church life, and where justice for all people was a given in how I understood the world. In one sense, I was ill-prepared for a part of the world that did not understand human life the way I did. Prior to that time, I'd had the opportunity to be in both Lebanon and Egypt. Lebanon is a country of deep religious diversity and multicultural realities due to colonial influence, particularly of the French. I was in Egypt right after Tahrir Square demonstrations while people voted on the new constitution, with the vote on Morsy having been seen as a manipulated vote and preparing the way for Al Sisi's election and ongoing power. In both countries, the Christian minority had influenced educational and medical institutions and often were the first providers of education for women. In Egypt, the Christian community has been growing in the last 5 years.

I have several presuppositions abut travel in the Middle East. One is that I read, read, read. I try to learn as much as I can. I try to formulate some basic questions for each trip to anchor my learning. And I expect to be transformed by the people I meet, to be rocked to my deepest core about the world and about faith. Last but not least, I go with empty hands. What I mean by that is that if I go with full hands I am so busy trying to empty them that I cannot receive the gifts of culture, faith, tradition, and land which are given to me daily. I encourage all our participants to go with empty hands for the same reason. I am a debtor to the people who walked the same roads that Jesus walked, who often know more about Biblical phrases than I, who remind me on the first day that they were the first to receive the good news of Jesus' birth – in the shepherd's field in Beit Sahour where the stars shone and sheep bleated and God was revealed in the birth of a child.

You will have the opportunity this afternoon to hear from this year's trip participants. After 9 years, I believe as your General Presbyter I have earned your trust enough to share with you my journey of faith and experience of politics. I hope so.

Let me also add that I grew up in a family committed to interfaith experience, and by that I mean Catholics and Jews when in the 1950s and 1960s that wasn't popular. My sister can still lead a shabbat service in Hebrew and my dad's library over-flowed with Jewish literature. When I was in high school he received the B'nai Brith Award for Human Relations

in a town of 45,000 in central Illinois. I grew up in a home where my sister and I were free to date across religious lines and did. And from these experiences I came to continue interfaith conversation and bridge-building in multiple places I served the church, including Grace Presbytery.

The mission study trips are exactly that – a time to see, to experience, to literally taste the multiplicity of cultures that make up Israel/Palestine and Jordan. We added Jordan to the trip for the last two years. Of course, seeing Petra is a treat. But seeing the religious mosaics reminded me of the same catechetical role of Italian frescoes for teaching people in the last 2000 years religious history. Walking in Jordan we walked across Edom and Moab – Moab the place where Ruth was from as she found her way to Naomi. And one terribly windy day this year we stood at Mt. Nebo on a balcony looking out over "the promised land" – the land which Moses was not allowed to cross into but stood looking at the vast expanse of land across the Jordan River. And we crossed over into a land that is called holy, but which is fraught with religious and cultural difference and inequities. What looked peaceful on Mt. Nebo is not so today, and truthfully it was land even for the Hebrews which they shared with other cultures and tribes and never belonged only to them.

I'm not sure what I thought Nazareth looked like, but it is now the third largest city, and an Israeli city. Cana, where Jesus turned water into wine, is a stone's throw away. Streets bustle, and the landscape is dominated by the Basilica of the Annunciation, a tribute to the Virgin Mary, modern in every aspect and reverent in its practice. Nearby we went to land that was originally Palestinian Christian – Sephorris – now taken over by Israel many years ago, made uninhabitable to Palestinians, and deliberately destroyed. We saw pictures of what it once was, saw a stream of clear water that is now periodically argued over by Jews and Palestinians. And on we went to see Father ("father" in Arabic is "Abuna") Elias Chacour, a well-known author and nominated 3 times for the Nobel Peace Prize, author of BLOOD BROTHERS, the story of his Palestinian village now destroyed in 1948. Almost 80, he tells the story as if it were yesterday.

But his story is not unique. When the British Mandate and the United Nations created Israel in 1948, perhaps no one not imagined what would happen these 71 years later. It's now documented that in the first several years of Israel, over 500 Palestinian villages were completely destroyed, and 750,000 Palestinians became refugees an have ever since been looking for the "key of return" to go home to the land some of their families have held for over 500 years. Repeatedly stories I've heard there and also from a Palestinian General Assembly Moderator (Rev. Fahed Abu Akel) tell me that Palestinians were told to leave for several weeks to Jordan or Lebanon and that they could come back to their homes. When they returned after several weeks, their homes were occupied by Jews, and their belongings were no longer theirs. They received zero compensation or ways to start a new life. Throughout Jordan and Lebanon, a Palestinian diaspora still exists where Palestinians left what had now become Israeli land.

Palestinians in the West Bank remained on their land, but much has changed there too. In 1947, Palestinian Christians made up about 25% of the population and today they make up 2%. In Israel and the West Bank, almost 18% are Muslim.

But back to what we experienced. Both Sundays found us in worship. The first Sunday at an Anglican Church in Amman, Jordan where we were warmly welcomed and invited to stay. The second Sunday we were at Christmas Lutheran Church in Bethlehem. Presbyterians have two mission co-workers there, one of whom Grace Presbytery supports – Victor Makari at Christmas Lutheran in Bethlehem, and Doug Dicks who lives in Bethlehem and assists with groups.

We moved from Nazareth to the north in Capernaum to see the synagogue where Jesus worshipped, the Sea of Galilee, the site where Jesus delivered the Sermon on the Mount and the Beatitudes, the Golan Heights and the fruit orchards. We broke bread and ate whole fish with a lot of tourists all looking out at the Sea of Galilee. Ask Rev. Will Wilson from Kilgore to tell you his experience post-lunch that day! And, we were treated to a traditional Palestinian meal – which is huge as well as delicious – in the home of our driver in Nazareth – a place where he and his extended family live on several floors. We laughed and discovered that barriers of culture and sometimes of language are not barriers when we pray together and discover the bonds of faith and friendship.

After several days we drove to Bethlehem where we stayed for 8 days. In day trips to Jerusalem, visited the Old City and walked the Via Dolorosa. We viewed Dead Sea Scrolls at the Israel Museum. We saw the Tomb of the Holy Sepulchre which is now being remodeled thanks to a religious agreement among several Christian branches. And we approached with solemnity the Church of All Nations and the Garden of Gethsemane. We were free to walk to the women's and men's sections of the Western Wall.

We heard from a Muslim scholar from Al Quds University whose adult children and grandchildren live in Dallas and who's visited us here. We worshipped with a Palestinian Human Rights organization, Sabeel, and met other Christians traveling internationally. We discovered how many tourists there are in this land, and also that the diversity of our experiences is unique. We learned that we had visits other people normally do not have. We visited an extended Christian family's land – for which they have physical title – where they are harassed by illegal Israeli settlements on 3 sides, where their olive and fruit trees are under attack regularly, where their efforts to get justice in Israeli courts are a daily effort in pushing for justice. We visited a Palestinian village, largely of Muslims, where another Israeli settlement has encroached on their village land and taken water from their water source. In that village there is often not steady electricity or water – true in many villages. Here we saw many casings from tear gas bombs and Israeli soldiers on the dirt streets, with weapons. We heard from parents whose children had been imprisoned, and some adults as well. We saw live footage of tear gas guns shooting 68 cannisters at one time and heard about some that shot 260 as well as foul liquid into homes. In my six years, I have visited this village three times and it is never better, and the settlement continues to grow. We visited with a businessman who holds jointly an American passport, having grown up in Youngstown, OH, and a Palestinian ID card and who created the first cell phone company in the West Bank, working now to bring industry to the West Bank. We heard from our tour guide that he, born in 1948, grew up being able to ride his bike 5 miles from Bethlehem to

Jerusalem, and raised four daughters who were forbidden by Israel to go to Jerusalem as Israeli regulations were put in place.

We visited a Jewish human rights organization as well as one which documents Palestinian home demolitions. We met in the home of an orthodox rabbi in the illegal settlement of Ephrat – a self-contained town of 9,000 people – and I heard him say to me two years ago that my Reform Jewish friends in Dallas with whom I planned the Interfaith Seder were not real Jews because they would know not to work with a Christian, especially a female minister.

So, in the midst of this holy land, we saw trauma, heard difficult stories, saw the preponderance of orthodox and ultra-orthodox Jews. We heard from young people who are secular Jews, many of whom live in Tel Aviv to get away from Jerusalem. Sometimes we drove on roads reserved only for Palestinians and sometimes on roads reserved only for tourists or Jews. Can you guess which roads were more direct and better equipped? We met Palestinian shopkeepers from Hebron to Bethlehem to Bethany. We visited just one of Bethlehem's refugee camps established in 1948, now with floor after floor on top of these UN provided homes, as one generation leads to another.

Let me say that we did not and will not go to Gaza, where we could not get permission to enter and there is no place to stay. It is as if Gaza is a separate country in its politics and in its distance from the West Bank.

After these years of travel, I no longer believe a two-state solution will ever be possible and whether or not a one-state solution is possible will be true only if all people are governed by the same laws and given title to their land. In every way I saw Palestinians who were made to be second class people in their own land. They do not have water or electricity regularly. They walk through turn-styles like cattle shoots to go from Bethlehem to Jerusalem to work. They are not allowed to fly out of Tel Aviv's airport but must add an extra day to their trip and travel to Amman, Jordan to fly out internationally. They do not ride the same buses or have the same license plates. They carry a sheaf of sometimes 17 different permits to do things we consider basic — each of which requires paying a fee, standing in a line, and sometimes being denied just because you happen to be Palestinian instead of Jewish. And as we walked, always in the back of my mind is "this is where Jesus walked and lived — how can it be like this today?"

Friends, this is what it means to travel with open hands – to receive the deep complexity of a society which compels military service for 18-year-olds (3 years for men; 2 years for women). It gives a pass to Orthodox Jews for military service and allows the Orthodox to receive welfare because they are steady students of the Torah and religious law rather than holding jobs. In this culture the populations which are growing are the Orthodox/Ultra-Orthodox and Palestinian Muslims. The West Bank which was partitioned for Palestinians in 1948 was over-ridden in the 1967 War. Since then, the Oslo Accord divided the West Bank into three regional areas – Area A for Palestinian control, Area B for Palestinian and Israeli control, and Area C for Israeli control. Illegal settlements according to both the Oslo Accord and the Geneva Convention now total 650,000 of the 9 million population in Israel and the

West Bank. The settlements make a two-state solution impossible. Israel's declaration that it is a Jewish and democratic state makes a peace agreement unlikely because Palestinians have no voting rights in the West Bank, no passports and no title to their land. Their cars have different license plates, not like the difference between Oklahoma and Texas, but so that no West Bank residents drive on Israeli roads.

I realize that this is not the image you normally get from the US press. Those of you who are my Facebook friends know that I often post articles and pictures designed to keep telling the story which is so often invisible.

The question, of course, is what to do about what we see. How do we engage each other in conversation, recognizing that there are people on both sides of these issues, and many of them genuine about wanting to share this sacred land? I hope you will come to the breakout group at 1 pm to see some pictures and hear from this year's trip participants. We are already scheduling next year's trip from April 29-May 13. The cost will likely remain at \$4000 which includes your transportation and room and board. Frankly, it's the bargain of a lifetime – to journey to this sacred land, to see it in all its complexity, and to be reminded of the deep faith that has grown there among three different traditions – Christianity, Judaism, and Islam. And to reflect with others in Grace Presbytery. We will worship with fellow Christians and be welcomed into their churches and be received into their homes. We go with empty hands to receive the gifts of these brothers and sisters in faith.

In closing, I'd like to quote Dr. Mitri Raheb, with whom we met and who was our guest at the October 2018 Grace Presbytery meeting: "Palestine was the unexpected place for God to reveal himself. The cross became the symbol for Palestinian identity. The ultimate revelation on the cross shows that there is no place on earth, in history, in one's own life where God cannot reveal himself. He is there where no one expects him, there even when we do not count on him, there when hope seems lost forever. The good news proclaimed on the cross was and is this: Expect God in the most unexpected places." (In a sermon preached at Duke University Chapel)

The question with which I leave you today is how we as American Christians can experience the land of Jesus and his profound message of peace and reconciliation, of justice for all people, and of hope that does not die. Join me.

The Presbytery Moderator, Rev. David Schaefers, presented his report. Rev. Gerry Tyer gave the report of the Stated Clerk and presented the Consent Agenda. The Presbytery Council report was given by Ruling Elder Phyllis Kidwell. Greetings were brought by President Steven O'Day of Austin College, and President Newell Williams and Dean of Faculty Michael Miller of Brite Divinity School. The report of the Nominating Committee was given by Rev. Matthew Curry. Rev. Karl Travis was recognized, and the Karl Travis Fund for Excellence in Ministry and Preaching was presented to the presbytery. The finance reports were presented by Rev. Marwood Meredith. Joys, concerns, and blessing for the meal were given by Rev. David Schaefers.

Three breakout groups convened after lunch: (1) An introduction to the General Assembly's Presbyterian Investment and Loan Program was given by Vice President for Sales and Marketing

Clare Lewis. (2) A report of the Israel Palestine Mission Study Trip was led by **Rev. Janet DeVries** and the other participants in the recent trip. (3) A presentation on property matters was given by Director of Property Management **Ruling Elder Karen Ebling**.

The Committee on Ministry report was presented by **Rev. Michael Waschevski**. The report of the Subcommittee on Examinations was given by **Rev. David Batchelder**. The Committee on Preparation for Ministry report was led by **Ruling Elder Betsy Winters**. The Congregational Support Committee report was given by **Ruling Elder Douglas Williamson**.

Motions from the Stated Clerk

- 1. Grace Presbytery approved the following amendment to the Vision and Bylaws of the Synod of the Sun concerning the plan for election of commissioners to the Synod of the Sun (new text indicated in bold italic font):
 - 3.1 The Synod Assembly shall consist of twenty-eight (28) Commissioners. One half shall be ruling elders and one half shall be teaching elders.
 - 3.1.1 Twenty-two commissioners shall be elected by the eleven presbyteries of the Synod. Each presbytery shall elect one teaching elder commissioner and one ruling elder commissioner, in alternating years, for a three-year term.
 - 3.1.2 Six commissioners (three ruling elders and three teaching elders from six different presbyteries) shall be elected as at-large commissioners to represent racial-ethnic constituencies. The Coordinating Team, serving as the nominating committee, shall make recommendations for at-large commissioners at the Fall Stated meeting. At-large commissioners are elected by the Assembly.

<u>Background and Rationale</u>: At the March 25-26, 2019 Synod of the Sun assembly at Ferncliff Camp and Conference Center, this amendment to the Vision and Bylaws of the Synod of the Sun was approved. However, before it can go into effect, it needs to be ratified by the constituent presbyteries of the synod. The Book of Order (G-3.0401) states "A synod shall determine a plan for the election of commissioners to the synod, as well as the method to fulfill the principles of participation and representation found in F- 1.0403 and G-3.0103; both plans shall be subject to approval by a majority of the presbyteries in the synod."

- 2. Grace Presbytery approved the following dates and places for the stated meetings next year: Saturday, February 22, 2020 (Dallas, First); Saturday, May 30, 2020 (Denton, St. Andrew); Saturday, September 26, 2020 (Austin College in Sherman); and November 14, 2020 (Richardson, Canyon Creek).

Statement of Faith: As a baptized child of the covenant, I am grateful for God's continued presence, guidance and actions in my life. It is through the Spirit of God that I became aware and responded to my specialized call to Ministry of Word and Sacrament. Each day is an opportunity to renew that response in faithfulness to a living, loving and still-speaking God who offers me, and all of humankind, reconciliation through Jesus Christ.

The Father, Son and Holy Spirit make up the triune reality of God. Each of these three persons enables us to experience God and enhance our relationship with God. God is the Creator, Redeemer, and Sustainer of creation who has called us into relationship with God and with one another as a covenant community, always nurturing us as we strive to fulfill God's purposes in our lives. Jesus is the truly divine and truly human Son of God, whose life and ministry bore testimony to God's reconciling plan of salvation. Ashley served at Evergreen Presbyterian Church in Dothan, Alabama. She is married to Lance Mertz.

Statement of Faith: I believe in a Creator who is beyond full human understanding, and is revealed through all of creation, with specific revelation through Jesus Christ and Scripture. God desires to be in relationship with all of creation, is revealed in new ways to every generation, and is creator and redeemer of all. This is the God of grace and mercy who offers love and reconciliation to all.

I believe Jesus Christ is the Son of God who became fully human for our sake, and Jesus was and is fully divine. Jesus was given to Earth at a particular time in history as the saving mercy for all who accept him as their savior. We know about Jesus through the testimony of the Gospels and he is the greatest example for how we are to live our lives. Jesus ministered without discrimination and with care for each person he encountered. Just as "Jesus proclaimed the reign of God: preaching good news to the poor and release to the captives, teaching by word and deed and blessing the children, healing the sick and binding up the brokenhearted, eating with outcasts, forgiving sinners, and calling all to repent and believe the gospel," so too are we called to the same ministry today.

I believe in the Holy Spirit as the third member of the Trinity. The Holy Spirit is the breath and action of God in and through humanity, and in the same way the Holy Spirit was given to Jesus through baptism, so too we receive the Holy Spirit. It is by the Holy Spirit that we are challenged and yet also encouraged in our faith. I believe God calls us through the Holy Spirit to be a Church that loves, challenges, and is faithful to one another in ways that make us stand out as examples of the Gospel message, as laid out in Scripture, and as we understand them through the Confessions.

I believe Scripture, while a "witness without parallel," should be approached with "literary and historical understanding" in order to ensure faithfulness to God's call to humanity and allowing for the Holy Spirit to speak to each group of people in their particular time and context.² In this

light, it is by the right preaching of the Word and the administration of the Sacraments as revealed through the witness of Scripture that we are united communally and individually with God. It is through the revelation of God in Scripture and the work of the Holy Spirit that we know we will never perfect God's full desires for our life and that it is by the death and resurrection of Jesus that we are invited into eternal fellowship with God. I believe it is through the Sacraments of baptism and communion that we express our relationship with the triune God and are thus sent out into the world to proclaim the ministry of Jesus, as exemplified in Scripture, and as the Holy Spirit calls us to do.

Rev. Kelly Staples

Rev. Kelly Staples is a lifelong Presbyterian who originally hails from the great state of Louisiana. She has a degree in Recording Industry Management from Middle Tennessee State University and received her Master of Divinity from Austin Presbyterian Theological Seminary in 2011. She served NorthPark Presbyterian Church of Dallas in a variety of rolls from 2011-2019. She is currently serving as Associate Pastor of Family Ministry at Trinity Presbyterian Church of Flower Mound. She lives in Arlington with her husband of 8 years, Garrett, their two daughters, and two terribly misbehaved cats.

Statement of Faith: I believe in God in three persons, a Holy Parent, Son, and Holy Spirit. I believe in Jesus Christ, the son of God, as the eternal plan of God for humanity and not a 33-year experiment or Plan B. Jesus Christ, who in his being was both completely human and completely divine, lifted humanity to God and brought us into participation with God. He had no sins of his own, but took our sins as his own and atoned for all humanity.

I believe in salvation through the grace of Jesus Christ and try to live my life as a thankful response to that grace. Motions from the Presbytery Council

1. Grace Presbytery approved the following funding for Presbyterian Church (U.S.A.) mission coworkers: 50% of salary support from Grace Presbytery in 2019 be designated for Rev. Victor Makari at Christmas Lutheran Church in Bethlehem; and 50% of salary support for Rev. Cathy Chang in Manila, Philippines and her ministry addressing human trafficking.

<u>Background</u>: This money is made available through a designation approved by Grace Presbytery from proceeds of the settlement between Highland Park Presbyterian Church and the presbytery. [4/24/19]

- 2. Grace Presbytery approved the following actions taken by the Presbytery Council as delegated by the Manual of Administrative Operations and received the items of information.
 - A. Approved a **Mission in a Changing Church** fund with up to \$250,000 per year from present interest income designated for the purpose of one-time congregational grants in an amount not to exceed \$30,000 per year and renewable only for one additional year. Congregations are encouraged to think creatively, and it's possible for multiple congregations to apply together. This amount would be in place for 3 to 5 years with annual review by the Presbytery Council with input from appropriate committees and Presbytery staff. The name of the fund shall be Mission in a Changing Church. The criteria for the use of these funds shall be the following. [4/24/19]
 - 1) The ministry should not be currently conducted by the congregation.
 - 2) The ministry should respond to a specific mission need identified through verifiable information or statistical information (such as Mission Insite or other information through the city/county of the church).
 - 3) No more than one-half of any grant shall be used for compensation of new staff. If the position is a ministry position, criteria for validating ministry through the Committee on Ministry will be applied in advance.
 - 4) The proposal for the grant shall document how the church will sustain the ministry (including staff) beyond one year.
 - 5) The budget for the program/mission shall be included, and there will be evidence of the congregation's financial stake in the ministry.

- 6) This grant is not intended for property enhancements or redevelopment.
- 7) The program should have a wide impact (beyond just a few people).
- 8) If the ministry is part of a larger Presbytery-wide emphasis (such as stewardship, new church development, or some other existing program area) there will be consultation with Presbytery staff and appropriate committee prior to the application.
- 9) Session action should be part of any application, including evidence of multiple people participating in developing the proposal.
- 10) The Presbytery Council moderator will appoint a sub-committee to review all applications and make a recommendation to the January meeting of the Council each year. Application criteria and announcements will be made from August to December of the previous year.
- B. Approved the following **Presbytery Council Strategic Plan** to guide the decision-making and leadership of the Presbytery Council. [4/24/19]

From Strength to Strength

A Strategic Plan for the Presbytery Council of Grace Presbytery

Psalms 84 says, "How lovely is your dwelling place, O LORD of hosts! My soul longs, indeed it faints for the courts of the Lord; my heart and my flesh sing for joy to the living God... Happy are those whose strength is in you... They go from strength to strength; the God of gods will be seen in Zion."

Going from "strength to strength" means thanking God for past blessings, facing the current situation with courage, and claiming the promise that God will bless us with new strength as we move into the future. Grace Presbytery has been blessed with strong congregations, dedicated pastors, generous disciples, committed volunteers, creative leadership, and effective programs and mission. As we look to the future, we give thanks for past blessings, acknowledge the challenges of today, and trust God to provide the strength needed for the future.

Our current strengths include:

- diverse ministries with youth and youth adults
- counseled guidance for those preparing for installed ministry
- a comprehensive resource center
- life-changing mission study trips
- assistance to churches seeking pastors
- effective administration of routine presbytery duties, including implementation of the presbytery mission budget, competently planned and led quarterly meetings, and responsive staff members

• increasingly broad communication to develop awareness of presbytery life and to teach others how to tell their stories

Some of the challenges facing Grace Presbytery today include:

- the decline of membership (especially youth) in many of our congregations
- the rising number of requests for help from congregations facing crises of various kinds
- the commitment to better serve the pastoral needs of ministers in the presbytery
- the expanding need to help churches reinvent themselves and redevelop ministry for a changing future
- the expanding need for Hispanic/Latino ministries
- the ongoing need to assist churches in finding new pastoral leadership equipped to lead congregations into an uncertain future
- the increasing number of congregations facing closure
- the growing demands of human and financial resources devoted to managing and use of property funds from closed churches to enhance present and future ministries
- the expanding complexity in our accounting system due to the added responsibilities related to church closures and shepherding restricted funds
- the need to find new sources of financial support for all the ministries and mission of the presbytery
- the increasing use and effectiveness of electronic media
- the need to imagine the future of congregational life through new forms of ministry and opportunities to work together with denominations with which we share working partnerships (for example, the Formula of Agreement)

Therefore, the following strategies will guide the future of Grace Presbytery, its committees and staff. The specific tactics of implementation will be left to the appropriate committee assigned to each strategy.

This is not a long-range plan. It focuses on the next few years during which important leadership and other changes will take place (such as the announced retirement of our General Presbyter).

- 1) The Presbytery Council with the assistance of the Youth Ministries Committee, Young Adult Ministry Committee, Congregational Support Committee, staff and others to design evangelism and outreach opportunities to reach youth, young adults and others with the Good News of the Gospel. Possible methods:
 - a) leveraging presbytery's strong youth and young adult ministries to reach beyond members of presbytery's current congregations
 - b) leveraging the resources of presbytery's Resource Center to provide printed and electronic resources to aide congregational programs of evangelism, mission, and outreach

- c) providing peer-learning groups and other training opportunities to presbytery's ministers and congregations to expand their programs of evangelism, mission, and outreach
- 2) The Presbytery Council with the assistance of the Committee on Ministry will design new ways to improve the effectiveness of the presbytery's ability *to respond to the rising number of requests for help from congregations facing crises* of various kinds. Possible methods:
 - a) adding conflict intervention to the responsibilities of COM members, adding staff or realigning staff responsibilities to include conflict intervention, and/or providing opportunities for education in conflict management
 - b) expanding the training of treasurers, clerks of session and pastors in polity understanding and facilitation
 - c) developing a session record review which helps the presbytery better understand and anticipate the issues facing congregations
- 3) The Presbytery Council with the assistance of the Committee on Ministry will design new and better ways *to address the pastoral needs of ministers* in the presbytery. Possible opportunities:
 - a) encouraging peer learning/caring/support/accountability groups among pastors
 - b) asking Honorably Retired clergy to volunteer their time as pastors to pastors
 - c) helping pastors find funding for professional counseling/mentoring/coaching
 - d) addressing pastoral care of pastors with present staff and volunteers
- 4) The Presbytery Council with the assistance of the Church Development Committee will design new ways to address the expanding need of churches to reinvent themselves and redevelop ministry for a changing future. Possible methods:
 - a) encouraging pastors of churches in need of redevelopment to form peer learning and support groups meeting regularly to hold each other accountable for providing creative leadership for change
 - b) assisting churches with vacant pulpits find a new pastor who is knowledgeable and experienced in congregational redevelopment
 - c) assisting congregations near the point of closure to finish their ministry in an honorable, dignified and celebrative manner
 - d) exploring at least one opportunity for a new ministry in Anna, Texas, and to do so with the Evangelical Lutheran Church in America beginning with a joint exploratory conversation

- 5) The Presbytery Council with the assistance of the Church Development Committee will design new ways *to expand presbytery's Hispanic/Latino ministry*. Possible methods:
 - a) leveraging presbytery's experience in racial/ethnic ministry by developing a strategy with the guidance of the Director of Ministry Services.
 - b) discovering effective mission partnerships with current Hispanic/Latino churches
- 6) The Presbytery Council with the assistance of the Administrative Commission on Property and the Board of Trustees will reorganize the elected groups currently responsible for property issues into a single unit in order to handle more effectively the responsibilities of receiving, managing and disposing of real estate property acquired by the presbytery from closed churches and other sources. Possible methods:
 - a) expanding the duties of the Board of Trustees as the primary unit overseeing the real estate and legal aspects of managing presbytery owned property and dissolving the Administrative Commission on Property
 - b) expanding the staff (or realigning staff responsibilities) in order that the staff has the time and expertise to implement property responsibilities
- 7) The Presbytery Council will design new ways *to address the increasing number of congregations facing closure*, the growing demands of human and financial resources devoted to managing and disposing of property from closed churches, and the expanding complexity in our accounting system due to the added responsibilities related to church closures and shepherding restricted funds. Possible methods:
 - a) adding a part-time property manager to oversee details with closing/dissolving congregations, property management, assessment of property use, and financial management.
 - b) assessing whether or not to continue outsourcing the financial management of the presbytery in order to ensure the financial system fully supports the complex funds and accounting needs of the presbytery
- 8) The Presbytery Council with the assistance of the Budget Committee and Board of Trustees will design new ways *to address new sources of financial support* for the ministries and mission of the presbytery. Possible methods:
 - a) designating all funds received by the presbytery from the sale of property to a restricted account, investing the corpus, and using the invested proceeds as an income supplement to the annual mission budget of the presbytery (except in those years when the entire amount of proceeds is not needed, and the residual amount reinvested in the corpus)

- b) determining an annual amount for use as presbytery loans or financial support to churches for extraordinary building issues not covered by insurance or annual budget
- c) determining a designated amount annually to be used to address particular program priorities for specific (annual) needs
- d) hearing from the Committee on Congregational Support, other groups, and individual recommendations, concerning specific needs and interests in the areas of: Christian Education, stewardship education, communication, officer training, peacemaking and international relations, mission study trips, immigration reform, interfaith and ecumenical service, young adult volunteers, college-age ministry, and specific racial-ethnic ministries, especially with immigrant groups. For example, at the present moment, we have a growing Ghanaian fellowship and Thai fellowship which recently relocated to new facilities.
- 9) The Presbytery Council with the assistance of the Director of Communication will design new ways to address and expand the effectiveness and use of electronic media. Possible methods:
 - a) redesigning the website
 - b) expanding the use of video conferencing
 - c) reimagining how electronic meetings are be utilized
 - d) developing the use of webinars

SUMMARY:

This strategic plan will be implemented by the Presbytery Council (using any of the listed strategies or others it may determine). It will be used to guide for decision-making and prioritizing for the next few years. Any opportunity requiring funding not included in the current budget will require specific approval by the Presbytery Council. As the Presbytery Council makes decisions to implement the strategic plan, it will be reported to the presbytery. This strategic plan will be revised, updated and reported on a regular basis.

- C. Received a report from **Rev. Harry Meissner**, Moderator of the Presbytery Council Task Force appointed to work with **Legacy Presbyterian Church**, **Frisco**. [4/24/19]
 - 1) Voted not to move forward with the proposal for Legacy Presbyterian Church, Frisco as presented at the January 30, 2019 Presbytery Council meeting.
 - 2) Elected the following to serve as an Administrative Commission for Legacy Presbyterian Church, Frisco to dissolve the congregation of at the request of the session: Rev. Harry Meissner (Moderator), Ruling Elder Ward White (Legacy, Frisco), Ruling Elder Debra Nelson (Legacy, Frisco), and Rev. Daniel Anderson-

Little in accordance with Grace Presbytery's Policy on Dissolution of a Congregation and in accordance with the Book of Order, G-3.0109b and G-3.0303e with the following duties and authority: meet with the session and members of the congregation, including calling a meeting of the session and/or of the congregation, as necessary, arrange for the pastoral care of the members, ascertain the financial status and outstanding financial obligations of the congregation, secure the session records, assume original jurisdiction of the session, if necessary, dissolve the congregation, dispose of the moveable personal property of the congregation, attend to matters of insurance, do such things and take such actions, for, in the name of, and on behalf of Grace Presbytery as shall be reasonably necessary to accomplish the general purpose of this resolution. An opportunity for nominations from the floor was afforded prior to the election.

- 3) Voted to retain ownership of the property owned by the presbytery in Frisco, and reserved the \$1,000,000.00 (designated by the presbytery from the closing of the John Calvin Presbyterian Church, Dallas) and the \$2,000,000.00 (from presbytery funds set aside by the Presbytery Council for Legacy Presbyterian Church) until the Church Development Committee can make a complete analysis of future prospects for a ministry in west Frisco.
- 4) Dismissed the Legacy Presbyterian Church Task Force with gratitude.
- D. Approved a \$2,000.00 scholarship for **Young Adult Volunteer Haley Whitson** (Dallas, Bentwood Trail) to help support her 2019-2020 service, and recognize her at the June 1, 2019 presbytery meeting. [4-24-19]
- E. Received a report from the Personnel Committee Moderator **Rev. Andy Odom**; and asked the Nominating Committee to nominate a slate of 6 to 7 ruling elders and ministers of Word and Sacrament to serve as the **General Presbyter Search Committee**, to be approved by the Presbytery Council, and to be elected by the presbytery in accordance with Standing Rule 1.4.16. The composition of the committee should meet the following criteria. [4-24-19]

Motions from the Administrative Commission on Property

1. Grace Presbytery received the following report of actions taken by Administrative Commission on Property in accordance with the authority delegated by the Manual of Administrative Operations and received the items of information.

First Quarter 2019: Property Update

- A. Presbytery-Owned Improved Properties (with church buildings) for Sale
 - Presbyterian Church:
 Property was listed for sale in April 2016 for \$1,119,900. The property was under contract for sale for \$755,000 to a funeral home company. The buyer canceled the contract after it was discovered that deed restrictions prevent the property from being used for anything other than a church. The River Oaks Economic Development Corporation and a City Council member have reached out to offer the Presbytery assistance in reviewing and addressing the deed restriction. The City Council has rezoned the area as commercial, where previously it was zoned as residential property with a church-only exception. In April 2019, the Administrative Commission on Property renewed the contract with Service Realty to list the property for another year. Ridglea Presbyterian is worshipping at the property for approximately one year, estimated until end of 2019, while its property is being renovated. In addition, a (non-PCUSA) Korean congregation worships there.
- B. Presbytery-Owned Vacant/Unimproved Properties for Sale

Our contracts have expired with the current commercial property development broker. The Administrative Commission on Property is reviewing brokers to represent these properties.

- 1) FOR SALE: 8851 North Beach Street, Fort Worth (Tarrant County): This property was purchased about 20 years ago for new church development and with assistance of a Bicentennial Fund gift from First Presbyterian Church of Fort Worth. The property is approximately 8 acres and is in a heavily trafficked area of Fort Worth with significant recent retail development. Anticipated sale price is \$1,500,000 to \$2,000,000. Commercial sales activity is increasing in the area.
- 2) FOR SALE: 600 Lake Ridge Parkway, Cedar Hill (Dallas County): The property was purchased by Grace Presbytery for new church development. The property is approximately 4 acres in a higher-end residential area. There are no plans to develop a church at this site. Estimated value is \$300,000. This has been on the market for some time with little response.
- 3) FOR SALE: 4517 E. Broad Street, Mansfield (Tarrant County): This property was used by the East Broad Outreach who notified Grace Presbytery of its intent to vacate the property. The property is approximately 10 acres with a small house on it. The property is bisected by a large cell tower constructed in 1983. The property is zoned

residential and is best suited for residential development. The Administrative Commission on Property retained a zoning consultant to rezone the property for larger residential lots to help with the sale of the property. There has been little or no activity on this property.

C. Presbytery-Owned Properties Held for Current Use/Future Decision

1) HELD (in use, not for sale): 2402 Crown Road, Dallas (Dallas County): Property with church building is used by United African Presbyterian Church. Using proceeds of the sale of the former Chapel Hills property, the presbytery spent approximately \$180,000 to renovate this space when United African was displaced from the Webb Chapel facility. We do not expect to do anything further with the property while United African is worshipping there. Property consists of the church building and an out-building used for classrooms and assembly.

D. Vacant/Unimproved Property Held for Future Decision

- 1) HELD: SW Corner Legacy Drive and Throne Hall Drive, Frisco (Denton County): The property was purchased by Grace Presbytery for new church development, and the location has been in active discussion for development with Legacy Presbyterian Church, Frisco. The property is approximately 9.4 acres and is adjacent to an elementary school where the congregation currently meets.
- 2) HELD: 1404 FM 1487, Crowley (Tarrant County): The property was purchased by Grace Presbytery for new church development. The property is approximately 13.33 acres and has a large gas well on it. There are no plans to develop a church at this site. The property is listed on the tax rolls at an appraised value of \$356,135, but a taxable value of \$24,498. The property is not on the market and may be difficult to sell as it is configured because of a gas well on the site.

Actions of the Administrative Commission on Property

- A. First Presbyterian Church of Allen: Approved a new contract on the sale of unused property.
- B. Nor'kirk Presbyterian of Carrollton: Approved an increase in the Presbyterian Investment and Loan Program loan for construction from previously approved \$500,000 to \$525,000. Deferred other financing requests to Committee on Ministry for discussion.
- C. First Presbyterian Church of Henderson: Approved oil and gas lease with Buffco Production.
- D. St. Paul Presbyterian Church of North Richland Hills: Considered and deferred request for 35-year lease of property adjacent to church building by City of North Richland Hills for the construction of a city park.
- E. Ridglea, Fort Worth: Discussed and declined request for transfer of church organ and speakers from current John Knox River Oaks property to new Ridglea Church building

when their construction is complete. The Administrative Commission on Property determined it is in the best interest to keep all church property intact until a decision is made regarding property and building sale, as the furnishing and fixtures could be desired by a potential buyer who is a worshipping community.

Motions from the Administrative Commission for First Presbyterian Church, Temple

- 1. Grace Presbytery received this final report and dismissed the Administrative Commission for First Presbyterian Church of Temple with gratitude.
 - A. The Presbytery Council elected **Ruling Elder Kenneth Johnson** (Temple, First) as Moderator, **Ruling Elder Cindy Miller** (Corsicana, Westminster) and **Rev. Deidre Carson** (Waco, First) as the Administrative Commission for First Presbyterian Church, Temple with the authority to dissolve the congregation.
 - B. The Administrative Commission voted to dissolve the congregation of First Presbyterian Church, Temple effective August 26, 2018. The Service of Witness and Act of Dissolution was held on that same date.
 - C. The Administrative Commission took the following actions:
 - 1) Monitored the process of the assimilation into Grace Presbyterian Church of Temple with a majority of the First Presbyterian Church of Temple active membership joining or attending Grace Presbyterian Church of Temple.
 - 2) Session records were delivered to Grace Presbytery along with financial records. Session records have been transferred to the Presbyterian Historical Society archive in Philadelphia.
 - 3) Satisfied the remaining financial liabilities of the church including copier lease, credit cards, bank accounts and service agreements. Final giving statements were prepared and distributed. Payroll and IRS reporting and filings were completed. Other notifications were completed.
 - 4) Approved the sale of the building and property to Redeemer Presbyterian Church (Presbyterian Church in America) for \$625,000.00 with net sales proceeds of \$576,833.50. The sale included all remaining moveable property not transferred to Grace Presbyterian Church of Temple or other churches.
 - 5) Recommend to Presbytery that the proceeds of the sale of the First Presbyterian Church building less administrative commission and presbytery costs related to the dissolution of the congregation be deposited in a fund identified as the First Grace Mission Fund or other suitable name determined by the Presbytery Council and Grace Presbyterian Church of Temple. The use of those funds will be subject to a plan presented by Grace Presbyterian Church and approved by the Presbytery Council. This plan is currently in process.

History of First Presbyterian Church, Temple

First Presbyterian Church of Temple, Texas, began its mission in a storeroom located on Main Street just north of the Santa Fe tracks in 1881. The formal organization of the church took place on October 19, 1881, making it the first church established in the town. A group of Presbyterian families who had been attending the Belton Presbyterian Church made an application to the fall meeting of the Central Texas Presbytery for the formal organization of the church. Twenty-four people presented certificates of their dismissal from the Belton Presbyterian Church and were enrolled as charter members of the church to be known as the Temple First Presbyterian Church.

The founding elders were A. A. Black and E. S. Crawford. The first deacons were J. L. Long and H. C. Black. For over 110 years there were members of the Black family in First Presbyterian Church. The impetus for the church began on June 29, 1881 when – during the festivities marking the sale of lots in what became Temple – the Gulf, Colorado and Santa Fe Railway offered a free lot to any religious organization which would build on it.

Mr. Black and Mr. Crawford, acting on behalf of the Presbyterian Church in the United States (sometimes called the "Southern Presbyterian Church"), made an application and received a lot located on the southwest corner of First Street and Barton Avenue in return for the sum of \$1.00. By September 1881 a plan for the new church had been laid out. By November, after Mr. Black and his sons had made a wagon trip to Calvert for the wood, the first church building in Temple was ready for its first worship service.

The first session meeting of what was then called Temple Presbyterian Church was held in the new church building on December 18, 1881 with Mr. Black as clerk. The first Pastor was Rev. C. W. Payton who was also pastor of Belton Presbyterian Church and came to Temple once a month to conduct services. The Sunday School met every Sunday and by Christmas of 1881 had 40 members enrolled. The Women's Missionary Society, later called the Women of the Church, was organized in 1885.

In 1892 the first building was torn down and a new and more spacious one built in its place on the same lot. The reason for the new building was the rapid growth of the church which had 134 members by April of 1896.

A Cumberland Presbyterian Church was organized in Temple in 1893, and in 1904 a movement to join the two was begun. By this time, the Cumberland church in Temple had moved over to the Presbyterian Church in the United States of America (known as the "Northern Church") and was called Grace Presbyterian. The attempt at union was begun because First Church was without a pastor and the two congregations were worshiping together in First Church building with services being conducted by Grace's minister. By this time the combined congregations numbered 224 members. The vote on union took place on September 27, 1906 but did not pass. Similar attempts to combine the two churches took place in 1912 and 1960 with the same results.

In September 1928 Dr. Michael MarYosip was called to pastor First Presbyterian. One of Dr. MarYosip's first actions was to ask for a congregation meeting to discuss the erection of a new church building. In March 1929, a lot was purchased at the corner of French Avenue and First Street; construction started in September, and the first worship service was held on February 9, 1930.

In 1938 the two Temple Presbyterian congregations shared the new building for several months while Grace Presbyterian Church looked for a minister. Their pastor had resigned in February of that year. Following the death of Dr. MarYosip on March 17, 1950, the congregation of Grace Presbyterian Church gave First Church much needed support until Rev. Harold Odum was called to become pastor.

Rev. Odum resigned in 1957 and Rev. Wilson Keenan, was called to became pastor the next year. Rev. Keenan served until December 1976. Dr. Ralph Person was called to the First Presbyterian Church pulpit in October of 1977 and served until December of 1996.

Dr. Dick Junkin came as interim pastor in May 1997 and was followed in that role by Rev. Sally Johnson who came in September 1997 and stayed until Rev. Margaret Boles arrived. Rev. Margaret Boles was called to assumed pastoral duties effective in August of 1998. Dr. Boles served until 2010. Rev Donna Knight served until her untimely death in 2011. Rev. Al Krumenacker served until Dr. Kenneth Ritchie was called and began serving the congregation in November 2012.

Dr. Ritchie served until the final service on August 26, 2018. The church continued its mission and outreach work including Churches Under the Bridge, Feed My Sheep, Family Promise, Meals on Wheels, Living Waters and Nicaragua Medical Missions. The congregation was active in mission and church activities with time, talent and financial resources. After several members died over the course of a few months, the financial position became problematic. The session voted to access the future of the congregation and the ministry at First and French. Based on that review, discussions (which began in 1904) were again initiated with Grace Presbyterian Church, the sister church in Temple, and a plan of assimilation was prepared. Under this plan, members were invited to join Grace, mission and outreach programs were transferred and First Church members were invited and elected to the session and the Board of Deacons. Also, certain physical items were brought from First Presbyterian Church to Grace Presbyterian Church. As a result, after discussions began 114 years ago, the two churches are now one, and the first nine months have been a Grace-filled experience of worshiping and working together.

Motions from the Examinations Subcommittee of the Committee on Ministry

1. Grace Presbytery sustained the examination of Ruling Elder Melinda Hunt as Commissioned Pastor and commissioned her to interim service at the First Presbyterian Church of Gainesville, Texas and authorized her to administer the Sacraments and to officiate at marriages in accordance with G-2.1001 effective May 5, 2019 to May 4, 2020.

Melinda Hunt

Melinda Hunt retired from Solar Under the Sun as Executive Director in December of 2018. Prior to joining Solar Under the Sun, she spent almost fourteen years as Director of Development and Ministry Services at Texas Presbyterian Foundation. Ms. Hunt belongs to Canyon Creek Presbyterian Church of Richardson, where she serves as a ruling elder. Melinda has been involved with the Presbyterian Church at the congregational, presbytery and General Assembly levels, including serving as a commissioner to the 223rd General

Assembly in St. Louis in 2018. Additionally, Melinda attended Austin Presbyterian Theological Seminary, where she currently serves on the Austin Seminary Alumnae Board. In her spare time, she and her husband, Homer Brown (and their little Cairn Terrier, Abbey), enjoy spending time with their kids and grandkids, traveling and hiking, especially in our national parks.

Statement of Faith: I believe in the one Triune God who poured love into creating all that exists, including humanity, then shared it with us to enjoy and preserve. This is a God who loved us enough to create us in God's own image, and called it not just good, but <u>very</u> good. A God who loves us enough to provide for our needs. A sovereign God who so desires relationship with humanity, that God sent Jesus, the Word incarnate, to teach us, show us how to love, care, learn, and be in relationship with him and others.

Jesus became our model for life and living, our mediator to God for our redemption. Jesus was fully human and fully God. Jesus cared enough to give his life that ours may be redeemed. Jesus was tortured, belittled and betrayed, yet rose above all to give us a glimpse of what is truly divine, what the kingdom of God should be and what love looks like. Yet, even being created in God's image, and having the incarnation of God in Jesus to show us how to love and live, we fail. We sin. It is part of our nature. Yet, because of the grace of Jesus we can live with full knowledge that Jesus has given the ultimate sacrifice that there may be victory over death, that our sins are forgiven, and we will take our place with Jesus when he comes again.

Jesus' birth, life, crucifixion and resurrection are evidence that God can bring goodness, grace and mercy even from hate, sin and hell. In the resurrection, God's love defeats death and evil. We are given the Holy Spirit to sustain and guide us along life's path. The Spirit guides when we're confused, convicts us when we sin, nudges us toward righteousness, justice and each other, and intercedes for us when we are unable to even know how to pray. These three, Creator, Redeemer, and Sustainer, are three in one. These three communicate with one another and with us.

We are given the Word, as well as the words in the Bible. The Bible is inspired by God yet communicated through people. While they were recorded in a different time, place and culture, they are words for us today. The Word is life-giving. We read of God's faithfulness, and of the saints who came before us - our heritage, the family of God. It is through the illumination of the Word that new life in Jesus is revealed to us. This is a life-long journey of growing into a likeness of him.

The sacraments of baptism and the Lord's Supper are gifts given by God to the church through Jesus. In baptism we are claimed as a child of God. It is through grace that we are baptized into the community of faith, God's family, as we seek to live out our faith. In the sacrament of the Lord's Supper, we gather together in the name of Jesus, pray together, eat and drink together, remembering that this gift is Jesus Christ. In community we receive this gift through faith and the Spirit. But this is not a gift to be hoarded. Just as Jesus did following his baptism, we are to go into the world sharing our faith and ministering to those in need. It is as we are claimed by God and given sustenance by the life and death of Christ

(bread and cup) and the Spirit, that we are able to reach inside and outside ourselves to experience and share the love of God with all that is.

We live as Christians, seeking to serve God in all we do because, ultimately, we know that the God who started it all will complete it all. God's kingdom will be made perfect. We know God reigns here on earth when we see what Jesus proclaimed around us; mercy compassion, justice, reconciliation, peace. This is what we are called to do and be, to build up God's kingdom on earth until Christ returns. We look forward to the ultimate, final kingdom, when Christ returns in the fullness of God's glory.

2. Grace Presbytery sustained the ordination examination of candidate Deanna Hollas as minister of Word and Sacrament.

Deanna Hollas

Deanna Hollas is being examined for ordination in order to serve as the Gun Violence Prevention Ministry Coordinator for the Presbyterian Peace Fellowship. Deanna graduated from Texas A&M University with a Bachelor of Business Administration in Accounting, earned her Master of Divinity from Southern Methodist University in Dallas, and received a Diploma in the Art of Spiritual Direction from San Francisco Theological Seminar in San Anselmo, California. Deanna is the co-founder of Retreat House Spirituality Center in Richardson and has served her home congregation Westminster Presbyterian Church of Dallas in various ways including youth group leader, Sunday school teacher, pulpit supply, and interim accountant (2007-2008). She has also served various other congregations in Grace Presbytery as pulpit supply. Deanna is married to Chris and they have two daughters, Emily and Eleanor and one son, John.

Statement of Faith: I trust in one triune God who creates, redeems, sustains, and transforms all things and all people. God's creative expression can be seen in all of creation as God is beyond limits and sovereign over all yet our human understanding of God is always limited. We can know the nature of God by looking at the life, death and resurrection of Jesus Christ as revealed in the scriptures. As God incarnate, Jesus shows God's power is not about domination but rather the humble willingness to take on the suffering of others and to care for the outcasts of society. Through Jesus we learn to love our neighbors as well as our enemies and to forgive those who persecute us. As human creatures we are created in the image of God which reflects life in relationship. The relationship between God, Jesus and the Spirit is one of equality and service. Yet because of sin we deny and distort our created being and are alienated from God and one another. In his death, rather than respond to violence with violence, Jesus takes into his body the world's violence and reveals it for all to see as he hangs on a cross. God overcomes sin and evil by resurrecting Jesus from the dead and ushers in a new world where death is not the final word. Empowered by the Holy Spirit we enter into God's continuing redemptive work. The Spirit is attested in the scriptures as ruach, the very breath of divine life that exists in and connects us with all things. The Spirit unites us with Christ and one another, pours the love of God into our hearts, gives us new life, helps us to pray, and liberates us for love of God and neighbor.

The church is called into being by God to proclaim the good news that in Christ a new creation has begun where all will be redeemed to engage in God's mission of freeing all from bondage and to serve as a faithful witness to the gospel's message of grace, peace and forgiveness. The church is the body of Christ - Christ's hands and feet, his very presence in the world. Through the Spirit and the gifts of word and sacrament the church is empowered and equipped as the body of Christ for this mission. Worship renews and nourishes the church for its work and through the sacraments the church embodies the Word of God. In baptism we are marked as Christ's own and called into community for service in the world. When the church gathers at the table, the Spirit draws us into Christ's presence, and we enact a new world of peace and equality that serves as a pattern for how we are to live as Christians in the world.

Scripture is inspired by God and is the unique and authoritative witness through which God is revealed. Where the word is faithfully read and proclaimed, the living Christ is present. Because God is beyond all our thinking and imagining, the Spirit calls us to constantly read and interpret scripture in community and to guard against our tendency to idolatry. It is through the creeds and confessions that the church declares what it believes and resolves to do in response to particular circumstances. The creeds bear witness to a church reformed and always being reformed. As partners in God's redemptive work the church uses its gifts to speak truth to power so that violence and injustice will be no more, and all will know Christ's peace.

3. Grace Presbytery recognized Bernabé Martinez (Fort Worth, Gethsemane) who completed his Certificate in Ministry at Austin Presbyterian Theological Seminary.

Wilson served as an intern for Eastminster Presbyterian Church of Dallas during the summer of 2019. He has served as an Associate Youth Director for First Presbyterian Church of San Antonio and as Praise Band Leader and Director of Christian Nurture for Oak Cliff Presbyterian Church of Dallas. Before beginning seminary, he was the Communications Coordinator for First Presbyterian Church of Dallas.
