Call to Order

The Stated Meeting of Grace Presbytery was called to order with prayer by Presbytery Moderator **Rev. David Schaefers** at 9:00 a.m. on September 28, 2019 at First Presbyterian Church of Tyler, Texas.

Offering

An offering of \$2,579.00 was received for the Camp in the Valley, a ministry of Mo-Ranch.

Quorum, Welcome, Docket

The moderator declared a quorum was present in accordance with the current version of the Standing Rules and Manual of Administrative Operations of Grace Presbytery, Section 1.5.3: "A quorum for presbytery meetings shall be ten percent of the teaching elders currently on the roll of the presbytery and one ruling elder commissioner from ten percent of the congregations on the roll of the presbytery." The docket was approved as presented. Host Pastor **Rev. Stuart Baskin** welcomed the presbytery. First-time ruling elder commissioners were recognized.

Gerry Tyer** gave the report of the Stated Clerk and presented the Consent Agenda. A presentation was given by **Rev. Maria Bock Barett** from the International Peacemaker Program of the General Assembly. The report of the Nominating Committee was given by **Rev. Lisa Juica Perkins**. The finance reports were presented by the Treasurer, **Ruling Elder Ken Johnson**. Joys, concerns, and blessing for the meal were given by **Rev. Lisa Patterson**. A video presentation about Mo-Ranch's Camp in the Valley was introduced by **Richard Bombach**.

Three breakout groups convened after lunch: (1) An introduction to the General Assembly's International Peacemaker program was given by **Rev. Maria Bock Barett**. (2) A presentation on Gun Violence Prevention was given by **Rev. David Schaefers**. (3) A discussion concerning Issues Related to Leasing Church Property was led by Director of Property Management **Ruling Elder Karen Ebling**.

1. Grace Presbytery approved the following Standing Rules changes regarding the Committee on Preparation for Ministry. (New text is <u>underlined</u>. Text to be deleted is in strikethrough font.)

Background: These changes will reduce the size of the committee from thirteen to twelve members at the request of the committee.

- 5.4.1. The Committee on Preparation for Ministry consists of thirteen twelve members composed of ruling elders and ministers of Word and Sacrament in numbers as nearly equal as possible. The General Presbyter (or designee) is an ex-officio member with voice but not vote.
- 2. Grace Presbytery approved the following Standing Rules changes regarding the Church Development Committee. (New text is <u>underlined</u>. Text to be deleted is in strikethrough font.)

Background: The committee is planning on a more robust program in the future especially in the area of revitalization. The committee needs twelve members instead of the current six members

- 5.6.1. The Church Development Committee consists of six twelve members, at least two of whom are current members of the Presbytery Council. A majority of members must be ruling elders and ministers of Word and Sacrament.
- 5.6.2. The committee oversees and supports new church developments, fellowships, new worshiping communities, and other partnerships created by the presbytery.
- 5.6.3. The committee provides support of the churches of the presbytery throughout the lifecycle of a congregation birth, vitality, and decline. The committee recommends to the Presbytery Council the establishment of new church developments. All such recommendations must include a plan for its financial support and ministry goals.
- 5.6.4. The committee duties include (1) supporting new church development pastors and Steering Committees, (2) guiding them in polity, process, evangelism, and congregational development, (3) helping them meet goals determined by the presbytery concerning membership, ministry and funding, (4) receiving reports from them quarterly, and (5) evaluating them at least annually.
- 5.6.5. The committee reports annually to the Presbytery Council on the status of each new church development with a recommendation concerning the next year of funding.
- 5.6.6. The committee may explore and recommend alternative forms of new church development.

Properties in Transition

Presbytery-Owned Improved Properties (with church buildings) For Sale

FOR SALE: 4350 River Oaks Blvd, River Oaks, Texas (Fort Worth, Tarrant Co)

Formerly John Knox Presbyterian Church

Current Listing Price: \$799,000

Property has been listed for sale since April 2016. Original price dropped from \$1,119,900 to \$799,000 after deed restriction concerns were raised by a previous buyer, limiting the property to church use only. Administrative Commission on Property has not taken action to remove the deed restrictions but may consider at a later date. River Oaks Economic Development Corporation and a City Council member have reached out to offer the presbytery assistance in reviewing and addressing the deed restriction, and we have sent them a letter detailing the issues. Ridglea Presbyterian Church is worshipping at the property for approximately one year, estimated until early 2020, while its property is being renovated. In addition, a (non-PCUSA) Korean congregation worships there during alternate hours.

Presbytery-Owned Vacant/Unimproved Properties for Sale

In July 2019, we signed new contracts with Church Realty (formerly Service Realty) to represent the following properties at a standard broker fee of 6%. They provided new/updated detailed Broker Price Opinions on each of the following properties, as reflected in the listing prices shown.

FOR SALE: 8851 North Beach Street, Fort Worth (Tarrant Co)

Current Listing Price: \$2,700,000

This property was purchased about twenty years ago for new church development and with assistance of a Bicentennial Fund gift from First Presbyterian Church, Fort Worth. The property is approximately 12 acres and is in a heavily trafficked area of Fort Worth with significant recent commercial development. In August 2019, we received two letters of interest from potential commercial development buyers requesting to start a due diligence process.

FOR SALE: 600 Lake Ridge Parkway, Cedar Hill (Dallas Co)

Current Listing Price: \$400,000

The property was purchased by Grace Presbytery for new church development. The property is approximately 6 acres in a higher-end residential area.

FOR SALE: 4517 E. Broad Street, Mansfield (Tarrant Co)

Current Listing Price: \$499,000

This property includes a house that was used by the East Broad Outreach, who notified Grace of its intent to vacate the property. The property is multiple parcels totaling approximately 7 acres. The property is bisected by a large cell tower constructed in 1983 and is under a leasehold agreement between the prior owner and MCI Telecommunications.

Presbytery-Owned Properties Held for Current Use / Future Decision

HELD (in use, not for sale): 2402 Crown Road, Dallas (Dallas Co)

Property with church building is used by United African Presbyterian Church, Dallas. Using proceeds of the sale of the former Chapel Hills property, the presbytery spent approximately \$180,000 to renovate this space when United African was displaced from the Webb Chapel facility. We do not expect to do anything further with the property while United African is worshipping there. Property consists of the church building and an out-building used for classrooms and assembly.

HELD: SW Corner Legacy Drive and Throne Hall Drive, Frisco (Denton Co)

The property was purchased by Grace Presbytery for new church development, and the location has been in active discussion for development with Legacy Presbyterian Church, Frisco. The property is approximately 9.4 acres. With the dissolution of Legacy Presbyterian Church in early 2019, we plan to hold all or part of the property for future use or sale. We have engaged a commercial broker to give us a Broker Price Opinion to sell a partial rear portion of the property.

HELD: 1404 FM 1187, Crowley (Tarrant Co) Broker Price Opinion: Listing \$499,000; realistic <\$300,000

The property was purchased by Grace Presbytery for new church development. The property is approximately 13.33 acres and has a large gas well on it. There are no plans to develop a church at this site. We have asked our broker/realtor to investigate possible buyers for parcels of the property given the gas well location on site, but the property is not listed for sale at this time.

Actions by ACP during SECOND QUARTER, April through June 2019

1. First Presbyterian Church, Rusk: Approved a sales contract for church-owned 0.5-acre estate property located near Decatur, Texas to a neighboring private buyer for \$12,000 "as is." (Update: This sale fell through, unable to reach price agreement with buyer.)

Motions from the Administrative Commission for Grace Presbyterian Church, Plano

1. Grace Presbytery received this final report from the Administrative Commission for Grace Presbyterian Church, Plano and dismissed the Administrative Commission with gratitude.

The Administrative Commission has completed all of the assignments given to it by the presbytery. An extensive report of all the commission activities was presented at the February 24, 2019 Presbytery Meeting.

Motions from the Administrative Commission for Legacy Presbyterian Church, Frisco

1. Grace Presbytery received this final report from the Administrative Commission for Legacy Presbyterian Church, Frisco and dismissed the Administrative Commission with gratitude.

- A. The Administrative Commission for Legacy Presbyterian Church, Frisco met May 15, 2019 and August 27, 2019. The committee was composed of Ruling Elder Kathy Foster, Rev. Daniel Anderson-Little, Rev. Harry Meissner (Moderator), Ruling Elder Ward White. Presbytery staff included Rev. Janet DeVries and Joanna Kim.
- B. The Administrative Commission for Legacy Presbyterian Church voted (1) to dissolve the congregation and (2) to dissolve the pastoral relationship between Rev. Daniel Anderson-Little and the church effective May 19, 2019.
- C. The Administrative Commission also took the following actions:
 - 1) The session record book was delivered to the presbytery office on June 1, 2019.
 - 2) An up-to-date membership list was delivered to the presbytery office on June 1, 2019.
 - 3) A final inventory of Legacy Presbyterian Church personal property was compiled by Rev. Daniel Anderson-Little and provided to the Administrative Commission.
 - 4) The follow dispositions were made:
 - a) Subsequent to May 19, 2019 the Website kept only the homepage to inform anyone accessing it that Legacy Presbyterian Church is closed and will contain links to nearby PCUSA congregations. The website will be fully deactivated in October 2019.
 - b) The Facebook account was deactivated on May 31, 2019. The Instagram account was deactivated May 9, 2019. The Twitter account was deactivated May 9, 2019.
 - c) The sign on the real property was removed after May 19, 2019.
 - d) The church-owned truck and 2 trailers was transferred to Can Academy, with contents (hospitality materials and chairs).
 - e) To give time for proper disposition, the rented storage unit was released, and property stored at the Presbyterian Mission Center.
 - f) All mail has been directed to Grace Presbytery subsequent to June 1, 2019.
 - g) The Breeze (church records program) account has been closed.
 - h) Kathy Foster, acting treasurer, paid the final Frisco Independent School District charge.
 - i) Insurance utilized by the Legacy Congregation was canceled May 31, 2019.
 - j) Kathy Foster provided the presbytery a final year-to-date financial statement.
 - k) The music director was given a severance gift of \$1,000, paid with residual Legacy funds.

- 1) A severance agreement with Rev. Daniel Anderson-Little will be paid through September 7, 2019 with residual Legacy funds.
- m) All remaining funds of Legacy Presbyterian Church were transferred to Grace Presbytery, and all bank accounts were closed.
- n) The closing service of worship at Legacy was held May 19, 2019 with General Presbyter Rev. Janet DeVries and Joanna Kim attending.
- o) Due to the dispersal of Legacy members, a written survey concerning reflections of the Legacy experience will be taken of as many former Legacy leaders as will respond, with opportunity afforded any who wish to add a verbal conversation. The tabulated results will be provided to the Church Development Committee.

Motions from the Committee on Ministry

Minimum Effective Salary for 2020

1. Grace Presbytery approved the minimum Effective Salary in Grace Presbytery in 2020 for Teaching Elders serving as a Pastor, Co-Pastor, Associate Pastor, Designated Pastor and for Certified Christian Educators in a full-time position will be \$50,000. [9/28/19]

- 2. Grace Presbytery approved the Honorable Retirement of Rev. Alan Baroody effective August 1, 2019. [7/16/19]

Mark served as pastor at First Presbyterian Cumberland Church of Alabaster in Alabama from 2004-2013 and Kardia Fellowship in Tyler, Texas from 2014-2015. Most recently he served as interim pastor at

Jefferson Cumberland Church in Jefferson, Texas from 2016-2019. Mark has 6 children and 2 grandchildren.

Statement of Faith: John 1:5 states, "The light shines in the darkness, and the darkness did not overcome it." This scripture is a guiding principle to my faith.

From the beginning, God has moved in love to bring order to chaos, light into darkness. God's abiding presence with humanity and creation is holy love. Outside of this love, that is shown to the world in the gift of faith, in unmerited grace, and in unending mercy chaos and darkness would reign. God's love is made known in multiple ways – holy scripture, prophets, the law, relationships, and in any other way God chooses to reveal – but, uniquely, God's love is made known in the person of Jesus Christ, the light of the world.

In Jesus Christ, God acts to bring salvation (wholeness) to a broken creation. Jesus' life of service, humility, and obedience which called together a diverse group of apostles and disciples established a new metric of greatness: the greatest among us is the one who serves. Jesus' life and teachings create a community whose purpose is to embrace all people with the gifts of grace, mercy, and love bringing light and life to the world. The community finds its conviction and power through the Holy Spirit.

The Holy Spirit connects and empowers God's people, gifting them to proclaim the good news of the kingdom of Jesus Christ through word and deed. In the Reformed Tradition, the outpouring of the Holy Spirit is fittingly symbolized by the baptismal waters poured on us at our baptism. The Spirit works on and through each of us, and the created community, to bring us to a closer relationship with God and one another knitting us together in a diverse and beautiful tapestry, breaking down barriers, and making us capable of accomplishing more than we have imagined.

As John 1:5 forms a guiding principle for my faith, the entirety of Romans 8 keeps me comforted in that faith. God loves us and works among us for good. Through the intercession of the Spirit, and in the love of Christ we are secure in our relationship with God. And, nothing, not one thing, will be able to separate us from that relationship of holy love.

Rev. Owen Gray

Rev. Owen Gray is currently serving as Associate Pastor for St. Barnabas Presbyterian Church of Richardson. He was ordained on July 30, 2017 at Village Presbyterian Church in Prairie Village, Kansas in Heartland Presbytery. Owen received his Bachelor of Arts in Political Science as well as a Bachelor of Arts in Classics and Religious Studies from University of Nebraska in 2013. In 2017 he received his Master of Divinity from Union Presbyterian Seminary in Richmond, Virginia. Owen served as Pastor Intern from 2013-2014 at Village Presbyterian Church in Prairie Village, Kansas. He served as Seminary Intern at Virginia Interfaith Center for Public Policy (2014-2016) and Three Chopt Presbyterian Church (2015-2017) in Richmond, Virginia. Most recently he completed a residency as a Lake Fellow in Parish Ministry (2017-2019) for Second Presbyterian Church of Indianapolis, Indiana. He and his wife Grace have a 3-year-old daughter Ruth.

Statement of Faith: I begin with this premise, so well-articulated by Karl Barth: "To say that God is, is to say that God loves." This is the lens through which I view the world and God's presence in it. Beyond that, I believe these things:

The creator God is driven by an insatiable desire for union with its creation. God pursued Adam and Eve, Abraham and Sarah, Moses and his people, and Israel through the ages. God's people, too, sought communion with their maker. Sin—separation from God that manifests itself in every relationship – kept that communion from being achieved. The prophets and wisdom writings offer fleeting witness to the full reality of God, though humanity could not yet understand it. God's heart broke over being separated from creation and did not tolerate it.

The whole of God's message is found in Jesus. Through the incarnation God transcended the chasm of our brokenness to achieve full unity with us. We can know God because God chose to know us in the flesh. In his ministry, death, and resurrection, Jesus was and is the Gospel, giving us eternal life, and demonstrating and demanding intentional, exhausting, self-giving love.

The Spirit is Christ's eternal presence on Earth. It calls us to shine the light of Christ into the murky corners of human existence. Such ministry is rarely glorious and rarely easy. The church takes courage, energy, and guidance from the Spirit to do so. Its mandate is the knowledge that the church is Christ's presence on Earth.

God, Christ, and Spirit – triunited – offer us a faith and life to the full. People of faith have always found meaning in the mystery of God's being and continue to today. In response to God's graceful presence in our lives, it is right to worship and give of ourselves. Baptism and Eucharist are uniquely universal means of uniting with the Triune God that connect people through time and place.

The purpose of the universal church, I believe, is to build faith in every person, by the Spirit's guidance, to the point that they can recognize their call to serve the world. The church ought to focus itself on service to all people, though Christ clearly calls us to give special energy and care to people experiencing powerlessness, poverty, hunger, homelessness, orphanhood, widowhood, imprisonment, displacement, injustice, and persecution.

I understand scripture to be the inspired word of God that is meant to feed our faith and give guidance and instruction in all parts of life. I believe that scripture and the church are an entirely and widely inclusive force; that God draws all people to Godself by a love that cannot be resisted. Finally, I have faith in life everlasting, and that Jesus Christ and the church are relevant today and for forever onward in the joy, comfort, hope, life, and love that comprise them.

Rev. Roger Harwerth

Rev. Roger Harwerth is currently serving as Interim Pastor of Ridglea Presbyterian Church of Fort Worth. He was ordained on December 19, 1987 in Sweet Springs, Missouri in Missouri Union Presbytery. Roger received his Bachelor of Arts at Missouri Valley College in Marshall, Missouri in 1983. In 1987 he received his Master of Divinity at San Francisco Theological Seminary in San Anselmo, California. Roger served as pastor at the following churches, Sweet Springs/Range Line Presbyterian Church (yoked parish) in Sweet Spring/Houstonia, Missouri, First Presbyterian Church of Hays Kansas, Borger, Texas, and Pendleton, Oregon. He also

served at Newport Presbyterian Church of Bellevue, Washington. Roger and his wife Brenda have three children. His son Chris Harwerth and wife BreeAnne who live in Odessa, Texas, daughter Amanda Shuster with husband Alex who live in Rowlett, Texas, and daughter Hannah Hannum with husband Ethan who live in Pendleton, Oregon.

Statement of Faith: I have a faith that is firmly cemented by the knowledge of God's love for me. Through my early years, learning the lessons of faith, and my growing years, stretching the limits of faith, and into my maturing years, living the complexities of faith, I have constantly known God's presence.

Expressed in terms of scale, I know God as Creator, as Parent. This aspect of the Trinity, which is so awe-filled, with universal scope and yet sub-atomic scale, often causes me to be amazed at the creation of which I am a part. That I am strong yet so fragile, that I am complex while also insignificant, that I am unique as well as similar to so many others – these are but a fragment of the joy and awe I feel toward God.

Expressed in terms of relationship, I know God through Jesus Christ, Son of God, Redeemer; God enfleshed and alive to the world, making known God's love which is for all. That God so loved the world that salvation became present through Christ is, as with God's creativity, an awe-filling reality which builds me up, and upon which I flourish.

Expressed in terms of motion, I know God the Holy Spirit, the Sustainer, the energy of discipleship. I believe that all I know and that all I feel about discipleship (that is, living the Good News) comes as a direct interaction with the Spirit. From the intrigue of not-yet-knowing to the assurance of familiar territory, it is the awareness of this Sustainer that fuels my life.

Making real this energy is the celebration of the sacraments and the practice of prayer. In baptism we rejoice in the infusion of the Spirit in our own lives and covenant to teach and learn from one another; in communion we invigorate our journeys of faith and nourish our understanding of Christ's significance to the world and our community of faith. Through both corporate and private prayer, we experience communication with God, lifting up burdens as well as joys, and opening ourselves to discerning God's will, individually and communally. I embrace prayer in its discipline, as well as its unplanned and unique character – breaking in and breaking forth throughout my days.

As an interpreter, a teacher, and a student of Scripture, I enjoy both the snapshots and the mosaic of faith that the Bible illuminates and with which I wrestle. I take seriously the study of Scripture and how we know and live its fullness; I also believe that Scripture opens us to God, through one another, not shutting us off from those we may deem different. One thing with which I am constantly struck is the great scope of persons encountered in Scripture and through whom (and, on occasion, in spite of whom) God works. Because God's participation with creation is that broad, I tread carefully on judging other persons and positions. Rather, I rejoice in God's love for me, and strive to model that love through Christ-centered care.

Rev. Terra Pennington

Rev. Terra Pennington is currently serving as Parish Associate at First Presbyterian Church of Longview. She was ordained at Mission Bay Community Church in San Francisco, California in

San Francisco Presbytery on March 7, 2015. Terra received her Bachelor of Arts in 1996 from Seattle Pacific University in Seattle, Washington. In 2013 she received her Master of Divinity from San Francisco Theological Seminary in San Francisco, California. She served at North Springfield Presbyterian Church in Akron Ohio and The Sanctuary Place in Kansas City, Kansas.

Statement of Faith: Living in obedience to a sovereign God who gives love, mercy and presence to a broken world, we are called with God's help to be a people of faith who live in community and display love, mercy and presence to each other and our broken world.

I believe in one sovereign triune God who touches all humanity with a grace that does not come because of any human action. I believe that all God's creation is good, but humanity pulled away from that goodness. God did not stop loving us in our failure and sent one who was sinless to reunite us with our loving Creator. Not capable of perfection, but with the help of the Creator, Redeemer and Sustainer to seek and do goodness, our good actions are done as a thankful response to this loving God who chose to reconcile humanity into an intimate relationship with God's self. The sacrament of baptism provides an outward sign of this grace and when a child is baptized, we recognize how God claim us as God's own even before we are able to utter our first word. The church is then to be a place where all members are enabled to foster an example of God's loving care for all of God's children.

I believe that Jesus came to us, being both God and also human at the same time. He showed us how to best live our lives, caring for the poor, being with the sick, attending to the needs of those that society rejected. He challenged religious and political authorities and for this was sentenced to death. He died and he was buried. He was resurrected after this death. Because of this resurrection we are able to be in full communion with our Creator despite our fallen nature that leads us to separation from God. In the sacrament of the Lord's Supper, we experience the mystery of God's presence among us. As Jesus celebrated a meal with his friends, we as one community together acknowledge his death and celebrate his resurrection. As Jesus set for us the example, through grace and power of the Creator, the Redeeming Son, and the Holy Spirit the church is called to care for all those in through words and actions, creating a world where God's kingdom is not just an abstract thought, but a tangible reality.

The Holy Spirit moves in concert with the Creator God and the Redeeming Son as the third part of the trinity. Through the Holy Spirit we are able to experience God's presence in our own lives, the lives of others and the world around us. Comforting us, the Holy Spirit illuminates the Old and New Testament scriptures, whispering to us to live out these teachings in our daily lives.
