## REGISTRATION INFORMATION

**What is Kidquake?** Kidquake is a weekend camp for elementary-age children to experience camp. They will participate in Bible learning, small group time, fun camp activities like canoeing hiking and games. They will meet kids from throughout Grace Presbytery. All three weekends of Kidquake provide the same experiences and activities.

**Beginnings and endings:** KidQuakes begin on Friday at 8:00pm and conclude before noon on Sunday. Three meals are provided on Saturday and breakfast on Sunday. Schedules are always subject to the weather.

**Who:** Kindergarten – 5<sup>th</sup> Graders and their adult sponsors.

(6<sup>th</sup> Graders invited if your church does not send them to Youth events.)

**Cost:** \$160 – includes 4 meals, housing two nights, programming, T-shirt

## Frequently Asked Questions

**IS SCHOLARSHIP ASSISTANCE AVAILABLE?** Scholarship assistance, generally 1/2 the cost of the event, is available to children. These scholarships are funded by the Prairie Valley Legacy Fund. To apply, parents must complete this [Online scholarship application](#)

Please note: **Our scholarship application process has changed and requires an online endorsement of the online application by a church leader! Parents must include your email on this online application.** After the application is completed, you will receive an email requesting that you endorse or reject the application on behalf of your church. Endorsing the application allows the scholarship team to know that the family is affiliated with a PCUSA church. **The application will not be processed by the scholarship team until we receive your response.**

**WHAT IS THE THEME FOR THIS YEAR'S KIDQUAKE?** Our 2025 theme is "God Has Done Great Things and So Can I!" We will learn the great things God has done through ordinary people like Miriam, Rahab, and Deborah and kids will think about how they can do great work for God. Our mission project, making personal hygiene kits for disaster victims, will give kids a real experience of how their actions can have a big impact on God's world.

### **WHAT DO I NEED TO KNOW ABOUT SPONSORS' RESPONSIBILITY AND BACKGROUND CHECKS?**

Background checks are required by Grace Presbytery, our insurance carriers, and the camp site. If your adult sponsor has not had a background check, you must do one prior to Kidquake. In addition, every adult attending must read and sign the Kidquake Community Covenant and appropriate camp Waiver of Liability. Sponsors must be present for the whole weekend and are responsible for supervising children.

### **I AM HAVING A HARD TIME FINDING SPONSORS. CAN OUR YOUTH STILL ATTEND?**

We want all youth to participate! We prefer youth to attend with adults from their home church to foster relationships that will endure past the retreat, but it is not always possible. If your church cannot send the requested sponsors, please contact Jen Bluestein ([jen@gracepresbytery.org](mailto:jen@gracepresbytery.org)) to discuss partnering with another church to sponsor your youth.

1. Collect registration information (name, grade, t-shirt size, special needs and dietary restrictions) and payments from children and parents and adult sponsors.

If you have not submitted a copy of your church's Approved Adult List this year or you are adding a newly background-checked adult sponsor, please submit the Approved Adult List form at the end of this document to Kat Studley ([kat@gracepresbytery.org](mailto:kat@gracepresbytery.org)) by the registration deadline.

**The registration deadline is two weeks before your selected Kidquake (March 14 for Kidquake #1, March 21 for Kidquake #2, April 11 for Kidquake #3).** Set your registration deadline for parents several days earlier so you will have time to follow up with parents who have not yet completed your sign-up process. No cancellations will be refunded after the registration deadline, but you may substitute participants up to the event day.
